Dear Members,

Where does the time go, soon to be Christmas, I think I missed the summer! My Father always used to say to me "as you get older time passes more quickly so make the most it" I always used to think, what is he on about, but now I am older I know exactly what he meant and how true his words are!

We are all saddened to hear of the passing of Wendy Hedley of the Starfire Stud, Wendy was a tremendous supporter of the Shetland pony. Her love of the Shetland could be seen in the ponies she successfully exhibited in the show ring, always immaculately presented and I much admired her homebred skewbald stallions. She was a lovely person and very much respected. My sincere sympathy to her family.

The probationary Judges Scheme remains closed at the present time but is under review by Council. However, Council has decided that it may, totally at its discretion, invite individuals who have made, in the opinion of Council, an outstanding contribution to the SPSBS and the Shetland pony, directly onto the Senior Judges Panel without restriction. This means that such individuals could judge all shows immediately. Council believes that in this way our Panel List will include judges who are of the most experienced kind who are respected for their knowledge of the breed and the show ring. Accordingly Mrs Debbie Barr and Mrs Jane Dennis have been invited to join the Ridden and Senior Panels respectively.

There have been concerns raised over the recent Sale under the auspices of the SPSBS at Aberdeen; these were mostly raised on a private web site. Council would like to point out that both a vet and current Council members were present representing the Society at the Aberdeen Sale. Ponies forward at any sale whether under the auspices of the Society or not which are in poor condition are the direct responsibility of vendors who have not cared for their animals correctly and humanely.

The SPSBS Society arranges and pays for a veterinary surgeon to attend the market the day prior to the sale and check ponies in the pens as they arrive for any veterinary/welfare concerns and also to attend on the day of the sale to again walk around the market and check ponies for any veterinary/ welfare concerns. Directly as a result of the veterinary presence two ponies were removed from the sale and veterinary assistance given. Relevant welfare organisations were informed and the SPSBS will maintain an open welfare file until the matter has been investigated by the RSPCA/SSPCA and closed.

I do not think there will be any sale in any livestock market in the country which will not have a sliding scale of standards of presentation of the animals on sale. This is all about people's own perception of presentation and stockmanship and indeed will vary greatly from individual to individual.

The vet also carries out any inspections and identifications required for export, in order to assist our Members with speedy and efficient foreign sales. The £5 plus VAT @ 20% charge per pony entered in sales replaces the 1% levy on all ponies sold. Council decided that this was a much fairer way of sharing the cost of providing staff and veterinary attendance at a sale held under the auspices of the Society. There are too many ponies entered in sales which are not forward on the day, often having been sold prior to it, and interested buyers may have travelled considerable distances to find animals not forward.

The Society finances office staff to achieve transfers on the day so that new owners can go away with their pony knowing all paperwork is correct and transfer of ownership has been completed and

passport updated. I would like to point out that the Society does get 99.9% of transfer revenue regardless of its presence at Sales.

Society staff are instructed to inform the RSPCA/SSPCA of any welfare issues and follow this up after the sales. Compulsory inspections were discussed but Council decided this would not be a workable option and have declined to proceed down this avenue. Many Council Members have seen poorly presented ponies at all the sales over the years and as disappointing as this is, there is no easy remedy for this.

The Council will continue to monitor this situation and provide veterinary attendance at any Society sale, along with Council Members and staff presence, with a reporting procedure to the RSPCA/SSPCA in place as well.

On a welfare note, it appears to me far too many ponies are being bred for economical gain; this can never be good for any breed. The Members who have remained within the Society through good and bad times and breed for the love and admiration of this versatile, charismatic pony and to maintain their personal bloodlines sensibly are the stalwarts of this Society and will remain so.

I would like to take this opportunity to welcome 169 new members into the Society, it really is good news to see so many new members joining the SPSBS. This demonstrates the continued enthusiasm for the Shetland pony and the SPS-BS.

On a personal note I have been heart warmed by the support and encouragement of the vast majority of the Membership, some of whom contact me regularly and really appreciate the workload and effort.

The result of whether to include the show results in the magazine has been answered conclusively by the Members and will therefore be included in the Society magazine.

The Society web site is currently being renewed and updated in order to address Members comments and reflect a more informative site in order that the correct and true information is communicated to Members speedily and easily.

I pass you over to your President for 2012, Mrs Joan Lambert, who I have worked closely with over the last two years and who I know will do a tremendous job.

May I take this opportunity to wish you all a very Merry Christmas and Happy New Year.

Anyone wishing to sell foals at any of the Society's autumn sales must submit their foal registrations no later than 4 weeks before the sale closing date. This will ensure that the office has enough time to process the registration, enter the details on the database (so the Auctioneers can check the entries) and for the passport to be issued to the breeder in plenty time for travelling to the sale.

EXPORTS/IMPORTS

Council would like to remind any members importing ponies to be cautious. The pony's lineage must trace back to the mother stud-books. It is up to the person importing the pony to prove the pedigree. Ponies must now be micro-chipped before they leave/enter the country.

It has been brought to Council's attention that some vendors are entering ponies into Society sales, but selling the animals before the sale takes place. This practice is unacceptable and unfair to potential buyers who, in some instances, travel long distances to bid for ponies only to get to the sale to find out they are not forward. We would ask that vendors please refrain from this practice.
