The Shetland Pony Stud-Book Society

Dear Members,

Firstly can I thank all of the many Members who contacted me directly to offer their continued support for the SPSBS and for the encouragement and best wishes to me personally.

Council met on February 11th and the smaller Council produced a very constructive meeting. The meeting closed after all the items on the agenda had been discussed and all council members had debated and put forward their views. Council appreciates that members have been concerned about price increases which are never welcome and come at a time when everything else is going up especially our hay and feed costs, but hope that members have understood why these increases were unavoidable and necessary for the running of the Society. In order that members may have a greater insight into the financial management of the Society, Council felt it appropriate that the Society Auditor Mr John Gellatly should address you directly in this newsletter.

It concerns me that there are a few Members who are struggling to understand the audited accounts which are circulated to each of you annually and presented at the AGM for members to debate if they so wish. As a result of this a few individuals appear to be circulating INCORRECT financial information. This may be simply an inability to understand audited accounts (hopefully it is not something more divisive) but I have heard that figures of a £90,000 loss over the last 5 years have been bandied about, which is INCORRECT and misleading, the correct figure for that period after you have taken off depreciation which is not a cash loss is a deficit of £22,351.

The support for our endearing Shetland pony continues with an increase in membership numbers last year. Registrations also increased and while these may well decrease for a while due to market forces the popularity of our charismatic little pony will never fade. Last year nearly 4000 foals were registered and it may well be more than the market can sustain at this level, therefore a decrease can only be of benefit to the breed. I hope that breeders will think carefully about putting mares in foal automatically every year, we do not want to be creating a welfare problem for our breed.

On a very positive note Council elected Countess De La Warr as the next Vice President, term of office to commence January 2012. I was delighted when she agreed to consider the position and feel that our next President Mrs Joan Lambert will have a very able and articulate Vice President. As many of you will know Countess De La Warr has a family history of Shetlands through the famous Fairy Ponies bred at South Park from the stud started by the Ladies Estella and Dorothea Hope in the eighteen seventies and the bloodlines in her ponies trace back to the first stud-book, something no other stud existing today can claim. Lady Estella was President in 1902. I extend my sincere congratulations to Countess De La Warr on her election as the next Vice President.

In order that ALL members are given a correct update regarding the financial position of the Society Council has asked the Society Auditor John S Gellatly LLB CA ATII to address you all with the correct information in this newsletter.

I attended the meeting of Council on 11 February as there were a number of matters that were to be discussed and it was felt I might be able to add to the discussions to help the Society to move forward. The topics on the agenda were price rises, attitude of OSCR (Office of the Scottish Charities Regulator), the constitution and staffing. My observations on these seemed to help the debate and Council asked me to write briefly for the newsletter so that the wider membership would be party, indirectly, to the relevant factors taken into account in arriving at decisions.

For the last few years, quarterly management accounts have been prepared by my firm and these are sent directly to Council members. These have shown a trend of losses confirmed by the annual report and accounts which all members get and the minutes of council meetings for the last 3-4 years show that when I have presented the audited accounts to Council I have advised that losses can only be sustained for a limited time before action has to be taken to stem these. This means either reducing expenditure or increasing income and the expenditure side has been scrutinised closely on a regular basis and there is little else to cut. The only feasible way of reversing the trend, therefore, was to look at the pricing policy for all the services provided to members and this was started in 2009 to apply for 2010 and then continued at the end of 2010 to apply for 2011. I was asked to calculate the likely effect of the rises assuming a similar number of transactions and this showed that the income would rise by around £50,000 which would eliminate the losses again suffered in 2010 and return the Society to surplus to start to replenish the cash reserves - having said that, this figure is probably greater than can be achieved as any price rise by any business inevitably leads to some reduction in activity and the realistic target is to aim for 80% of the maximum. I believe that this was the correct action, particularly as prices had not been altered since 2004. There are a number of other matters taken into account by Council that require to be borne in mind to remove any doubt about the position. Firstly, over the last five years (and I take that period to cover from 1 January 2005 to 31 December 2009, that being the end date of the last published accounts), the audited accounts of the Society show a surplus of £16851 in 2005, with deficits for the following 4 years of £(534), £(24724), $\mathfrak{L}(12994)$, and $\mathfrak{L}(22428)$, which cumulatively total $\mathfrak{L}(43829)$, with further losses likely again in 2010, and that identifies the position to be dealt with by Council. Secondly, the quarterly accounts being produced allowed spending to be managed and that is certainly the case. There are two items in the accounts, however, that are not so easily controlled and these are depreciation and legal fees. Depreciation is not a cash expense but a measure of the use of fixed assets over an accounting period to reflect the contribution made by these assets to the running of the Society and the total appropriation over the period was £21478 which represents the major part of the overall deficit. Legal fees cannot be budgeted for annually as these are only incurred when Council has to seek advice from the Society solicitors and this happens only when a matter arises. Over the period there have been a number of occasions when this has been necessary on employment and redundancy matters, dealings with EU disputes and the like and it is disingenuous to say that Council should not have incurred that expenditure as it was clearly in the interests of the society to do so. For your information, further legal fees were incurred in 2010 to deal with amending the constitution after indications from OSCR that the existing one was not acceptable. The dilemma faced by Council is explained in the next paragraph.

Next, as just referred to above, the attention being paid by OSCR to agricultural organisations and societies were discussed, with the particular aspect of retaining the charitable status of the Society for the future. It was made clear in early 2010 that the examination of 3 different organisations carried out in 2009 resulted in their respective constitutions being challenged and each was told changes had to be made. Two did so and retained their status but one did not and lost it and this emphasises how important making the necessary changes was.

If your Society had lost its status, it would also have lost its assets as these would have been taken away and given to another charitable body and the Society would have ceased to exist. Your Council, therefore, had to act and the correct process was put in place. I am aware, too, of a very large organisation that held a Board meeting in January under the threat that if it did not vote to change on that day, it would be closed down and OSCR, thus, has significant powers.

Following on from that matter, the cost of the legal fees was aired and the way in which these escalated is set out clearly in the December 2010 newsletter. Obviously, the total of these contributed to losses made and it is to be hoped that there will be less need for the Society to take legal advice in the future as this will help to restore the finances as this is one area of expenditure that can be reduced. The draft of the new constitution was approved by OSCR prior to the AGM last October and this showed the benefit of Council identifying a problem, dealing with it and ensuring the continuation of your Society.

Finally, the level of staffing was looked at and the question was asked whether there were too many and whether a member of staff should be made redundant. Again, the December news letter points out the increased duties being undertaken by staff and this indicates that the staff are fully occupied. If a job that office staff do exists, and keeps the person doing it fully occupied, it is difficult to see how an individual may be made redundant in that it is the job and not the person doing it that has to be redundant. If a member of staff is made redundant but the duties are then spread around others in the office, that is not redundancy but unfair dismissal and would inevitably lead to a hearing at an Employment Tribunal which has the potential to be very expensive."

Passports will continue to be sent by ordinary post. If you wish your passports to be returned by recorded mail, please ensure you include the postage when sending documents in to the Office. If you are unsure of the postage rates, please contact the Society office for clarification.

We are pleased to welcome Claire into the position of Office Manager, where she will assume additional secretarial duties. Claire is well known to all members and has always taken her duties responsibly and efficiently whether in the office or out amongst the membership.

Registrations

Anyone wishing to sell foals at any of the Society's autumn sales must submit their foal registrations no later than 4 weeks before the sale closing date. This will ensure that the office has enough time to process the registration, enter the details on the database (so the Auctioneers can check the entries) and for the passport to be issued to the breeder in plenty time for travelling to the sale.

EXPORTS/IMPORTS

Council would like to remind any members importing ponies to be cautious. The pony's lineage must trace back to the mother stud-books. It is up to the person importing the pony to prove the pedigree. Ponies must now be micro-chipped before they leave/enter the country.
