INSTRUCTIONS FOR COMPLETION OF PASSPORT FORM

Please read these instructions carefully before completing the attached foal registration form. .

Please do not use any old forms you may have. These are no longer valid and any registrations which are submitted on the old forms, will be returned. Only original forms from the Office will be acceptable.

Foals must be registered before they are 6 months of age or by 31st December in their year of birth (whichever is later). Any registration received outwith these timescales will result in the passport being stamped "duplicate".

It is important that you write clearly and in capitals as the identification drawing will be scanned directly into the passport.

Please use a black pen. White markings must be drawn in red ink.

Normal "horse" colours may be used. "Dun" or "roan" alone should not be used – add a colour e.g. blue roan or cream dun.

You must complete sections 1(b), 2(a) & (b), 3(a) – (h) and the markings on the identification drawing.

If the pony has no markings (solid coloured) and has less than 3 whorls, then you must complete the Chestnuts section. In each corresponding box you need to outline each chestnut on the pony's legs.

Your vet must complete section 5 and stamp and sign the boxes above the identification drawing.

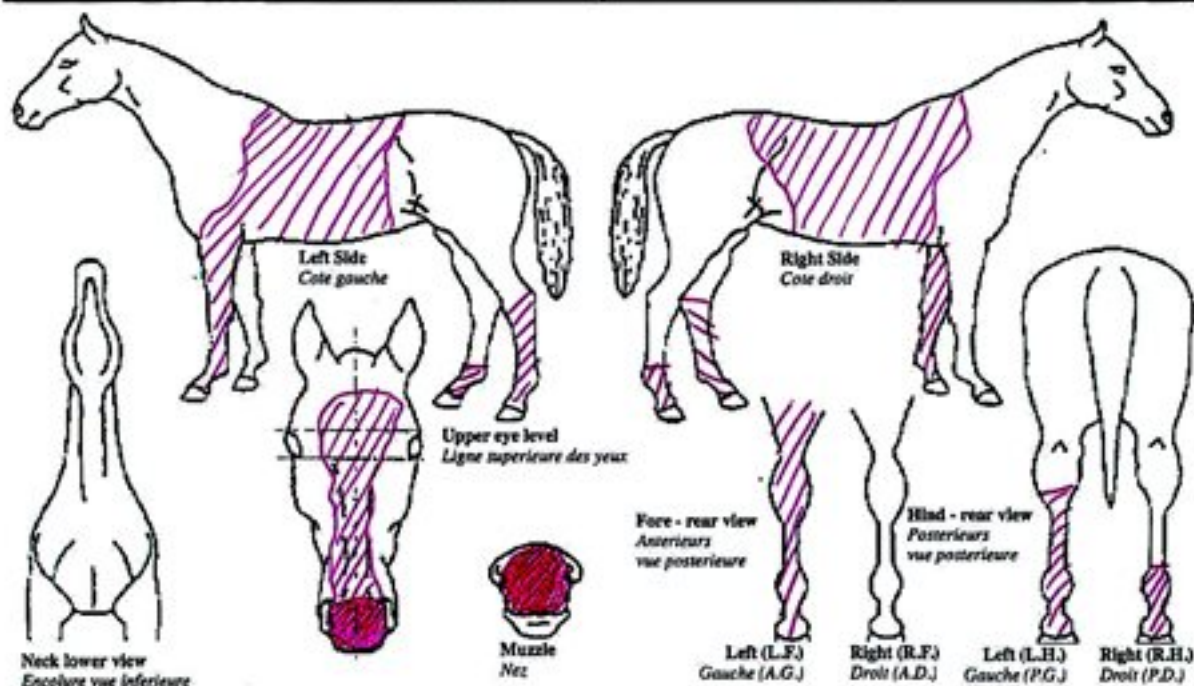
